- Advocated for options allowing new members/ retirees to avoid offsets to potential SERS survivor's benefits.
- Successfully took 2 lawsuits all the way to the Illinois Supreme Court to preserve and protect the healthcare and pension benefits of retirees.
- Maintains effective representation at the Illinois Statehouse, who reviews the over 10,000 bills introduced every legislative session and protects the interests of our members.
- Vigorously opposes legislation that would in any way divert pension funds from their sole purpose of providing benefits to pension system members.
